Complaints

2023/101 Reply received from NRW re: maintenance of Sarn Wen ditch to say that due to Health & safety regulations they are unable to clean part of the ditch by the exposed sewer. They have explained that it is the duty of the owner of the land to clear the ditch. Councillors felt that the parts of the ditch thatthey can clean should be done immediately.

2023/102 The issues with the porous embankment opposite Rhandregwynwen has been reported to NRW, Powys County Council inc the Trunk Road Agency. NRW have confirmed that it is their responsibility and they will carry out an assessment shortly.

2023/103 Clerk reminded Trunk Road Agency of the urgent need to add a pedestrian crossing warning sign on the approach to the roundabout on the A483. PCSO has also replied with advice on how to report anyone contravening a red light on Gosafe-Op.snap. Clerk to ask where there is another corssing in Powys on a Trunk Road.

2023/104 Clerk has reminded Hafren Dyfrdwy of their promise to survey the sewers along Canal Road to try and eliminate the groundwater.
