<u>Minutes of the last meeting</u> held on Thursday 26th October 2023 had been circulated. The Minutes were approved and signed by the Vie- Chairman. 2023/593

Matters arising from meeting of 28th September 2023.

2023/594 (2023/544) Cllrs were concerned that the reformed Severn/Vrynwy Liaison Group will only consist of Government organizations and not any representation from local residents. Clerk to email Russell George and County Cllr Arwel agreed to email the Chairman of the group County Cllr Jonathon Wilkinson. 2023/595 (2023/545) Highways reminded re: use of external contractors/equipment

2023/596 (2023/546) There was a good attendance at an Open Meeting held on Wed 15th November at 7 p.m in Llandrinio Village Hall to discuss the report produced by Powys County Council. Residents had explained that most of the problem is caused by vehicles travelling too fast over the Bridge and that the traffic lights need to stop each vehicle. There was also a presentation from the Severn Valley water Management Team who explained what they were trying to achieve in slowing the flow of the water – residents felt that compensation needs to be included in the future for those farmers whose fields are holding water more often and for longer periods.

2023/597 (2023/564) Update received from Canal & River Trust together with details of how volunteers can adopt a section of the Canal. Request had been received for a letter of support as part of the Heritage Lottery Application to repair Vrynwy Aqueduct and this has been sent.

2023/598 (2023/573) Following another Burglary in Sarnau signs for Neighbourhood Watch have now been ordered by the Neighbourhood Watch Co-ordinator –approx cost £100

2023/599 (2023/579) Concerns re; inadequate signage at roundabout on A483 have been referred back to North & Mid Wales Trunk Road Agency

2023/600 (2023/400) Land Search now returned in respect of Golden Lion (now Ty Llew) which shows that no planning permission has ever been granted for the Holiday accommodation to be permanent residential use. Clerk to notify planning Dept.

2023/634 Powys County Council reminded of the problems of flooding at the entrance to School/Village Centre – County Cllr Arwel will ask the Highways Inspector to come and visit.

2023/635 Welsh Gov have responded to Powys Inland Drainage District reminder about adopting a section of the Sarn Wen Brook behind the Stores to say that it has been 7 years since the consultation was carried out and they feel they now need to re-consult. It was agreed to reply that the

situation/landowners/stakeholders has not changed and that this 200m section needs adopting without any further delay.

2023/636 Blocked drain outside Domgay House also reported again

2023/637 Powys County Council have confirmed that they will write to Mr David Lloyd to trim the hedge which is obscuring 2 of the street lights by the Old Creamery

2023/638 Clerk has contacted Highways to request the reinstatement of 2 verge markers outside The Oaks, Domgay Lane – also complaint received about the depth of the verges – making it very difficult for pedestrians. Highways Inspector will be taken to visit.

2023/639 Highways have responded to request for pavements to be cleared to say that volunteers could do within the Housing Estates but not along the B4393 – it was agreed to wait until the Spring and then form a working party.

2023/642 Highways Dept reminded to replace the missing Village sign of Four Crosses on the approach from Llandrinio and also to add 'Llandysilio'

2023/643 Engineers have re-visited the Traffic Lights at Clafton Bridge and these are now back to a sensor timing.

2023/645 Clerk to notify NRW of flood being deposited in the flood plain by Llanymynech bridge and also Manure stacks behind Ty Coch.

2023/646 Graffiti has started to appear at Foxen Manor –Cllr D M E Lloyd offered to go and try and clean it off.
