Draft Minutes of a meeting held on Thursday 26th January 2023 in Four Crosses Village Centre at 7.00 p.m (also accessible via zoom)

<u>Present</u>: Chairman Cllr Frances Buckingham, Cllrs D M Foulkes, Mrs D Kendall , E A Jones, W J Lee, D C Harris, C M Jenner, Mrs V Holloway and D M E Lloyd

Apologies were accepted from Cllr N H Savage and condolences were given to Cllr Arwel Jones. 2023/1

<u>Minutes of the last meetings</u> held on Thursday 24th November 2022 and 21st December 2022 had been circulated. The Minutes were approved and signed by the Chairman. 2023/2

Matters arising from meeting of 24th November and 21st December 2022.

2023/3 (2022/478) Notice has been put up in the Bus Shelter at the bottom of Domgay lane to try and find out if anyone uses it. Resident had written to say that the lay-by opposite the Former Spar Shop is too small for some of the buses and wondered if the newest bus shelter, at the bottom of Domgay Road, could be used more often. Cllrs agreed to continue to press Powys Couty Council to repair 2 of the existing bus shelters. 2023/4 (2022/484) Letter sent to Matt Perry Head of Highways re: Home to School Transport Policy in respect of Llandysilio Church in Wales School. Reply received with a copy of the email that was sent to the School re; the catchment consultation - they have now spoken to the School who have confirmed that this was never received and are arranging a meeting to discuss further.

2023/5 Apologies had been received from Matt Perry who had agreed to join the meeting to discuss the availability of gully emptiers and road sweepers. He had sent a summary of the equipment currently being used which included some hire vehicles. He was prepared to join another meeting to discuss further. 2023/6 (2022/519) Grant bid for Neighbourhood Watch Scheme submitted by Brian Foulkes has not been successful as demand outstripped the fund available. Signs are £6 each. It was agreed to purchase 10 signs. 2023/7 (2022/542) Donation request from Little Tysilio's towards the cost of adding a 3 ft paling fence in the playground for use by the Pre-School. Estimate of £427.90 received. Cllrs W J Lee, Mrs V Holloway and D M E Lloyd declared an interest and withdrew from the meeting. Cllrs noted the positioning of the fence and this would not affect larger vehicles accessing the Village Centre. It was proposed by Cllr D M Foulkes and seconded by Cllr D c Harris that a Grant of £400 be awarded. Little Tysilio's is currently awaiting registration with the Charity Commission and Care Inspectorate for Wales but once this has been finalized a cheque will be sent.

2023/8 (2022/521) With regard to the donation request to replace the goal posts at Llandysilio School it was noted that the Deytheur Trust Foundation had given a Grant. Clerk to check if there is now any shortfall in funding.

Sports & Recreation

2023/9 Thanks were given to Cllr Cliff for completing the Maintenance log for December. Cllr D M E Lloyd offered to complete for February.

2023/16 Charis Denham, Planning Officer, has made contact as part of the initiative by County Cllr Jake Berriman for each Community Council to have an appointed Planning Officer who will maintain regular contact.

2023/17 Additional information received in respect of 22/2012/RES – Reserved matters application re: erection of 24 affordable dwellings at land adj The Street – site plan and 3D views enclosed. Response to concerns raised by Highways have also been lodged on the Planning Portal. Letter also received from Barcud addressing some of the concerns raised by the Community Council. They confirmed that the houses would be built to a very high sustainable standard with air source heat pumps or solar panels. They also confirmed that the properties would be affordable in perpetuity – Clerk to ask how many for sale and how many for rent and also to ask with regard to those for rent whether the Landlord keeps the income from the Solar panels. More clarification needed as to whether the other existing chicane has to be moved as this is mentioned in the response from the Highways dept. Architect had also explained why the hanging red tiles on the walls had been agreed – Clerk to also check colour of roofs and who would be responsible for the maintenance of the Open Space. And that the Objection will remain.

2023/54 Complaint received from runners that many motorists are ignoring the red light at the pedestrian crossing – Clerk has asked for more details of time and date and passed it onto the PCSO. Clerk to remind Trunk Road Agency as they promised a signage review.

2023/55 Complaint received by NRW of material being deposited in the flood plain opposite Calcott Hall – being investigated

2023/56 Many thanks to Mr Stuart Page who collected the Severn Trent signs by the roundabout 2023/57 Update following recent flooding – embankment opposite Rhandregwynwen is now very porous and causing a deeper flood.Clerk to notify NRW and Powys County Council.

2023/58 30 mph signs were used when the flooding was happening but not putting out early enough 2023/59 Agreement may finally be reached to change the regulatory level of the water in Lake Vrynwy and

Clwydeog but the legal process could take 2 years

2023/60 Complaint received of sewage coming into properties during the wet weather down Canal Road – Clerk emailed Severn Trent and they have acknowledged the problem and have promised to do a camera survey to see where the ground water is seeping in.

2023/61 Proposed closure of Llandrinio bridge has now been postponed until more details of the proposed implementation of bollards to reduce width to 3.1 has been consulted on.

2023/62 Clerk to contact organisers of the Welshpool Tractor Run held in Dec to ask them to take down the signage

2023/63 Resident's have complained about tractors using the B4393 which are over 7.50 ton – Cllr Arwel offered to contact the owner of the Contracting Firm

2023/64 Clerk has reported a blocked gully on City Lane opposite the entrance to the Old Post Office Gardens.

2023/65 Clerk to ask Canal & River Trust for more signage to show the way onto the Canal from Clafton Bridge
