<u>Draft Minutes of a meeting held on Friday 29th July 2022 in Old School House at 7.30 p.m</u> (also accessible via zoom)

Present: Chairman Cllr Frances Buckingham, Cllrs D M Foulkes, E A Jones, Mrs V Holloway, D M E Lloyd and W J Lee plus 1 members of the public.

Apologies: 2022/310 Cllrs Mrs D Kendall, D C Harris, C M Jenner and N H Savage.

Chairman welcomed the Member of the Public who raised the following concern;-

2022/311 That following the meeting held on the 30th June there had been a breach of confidentiality and that details had been given to a third party of what had taken place during the meeting and who had been present. Chairman explained that it was a Public Meeting so there was no breach of confidentiality and that there was no evidence that any personal data had been given by a Councillor to a Third Party.

<u>Minutes of the last meeting</u> held on Thursday 30th June 2022 had been circulated. Clerk explained that an email had been received from a member of the public present at the meeting who felt that further information should have been included in the Minutes and included in the response to the Planning Dept re; Erection of 3 log cabins at Laburnum House Brynmawr. Clerk explained that the Minutes reflected the decision made by the Community Council and that all relevant factors had been included in the Planning response as agreed at the meeting. Matters arising from meeting of 30th June 2022

2022/313 (2022/250) Clerk contacted the new Portfolio Holder County Cllr Jackie Charlton re: the 3 bus shelters in the Village & she has confirmed she will chase John Forsey for a reply.

2022/314 (2022/254) Poster had been circulated detailing the Puppet Workshops on the 10th & 1 th August 2022/315 (2022/245) Following visit by members of Llanfyllin Surgery contact has been made with the former Chair of Llanfyllin PPG and date set for a meeting in September. Suggestion also made by member of public present of improved signage by NIBS to show location of Medical Centre. This has been passed onto the Medical Centre who will take it forward.

2022/316 (2022/246) Updated Register of Interests had been circulated together with guidance notes – Clerk reminded Councillors to please notify of any changes that occur during the year.

2022/317 (2022/291) Shrubs by No 58 Parc Hafod have been trimmed – Clerk has checked with owner and he is satisfied with the work. Invoice for £450 received.

2022/318 (2022/308) It was agreed to proceed with the purchase of a Book of Condolence (approx £22 + VAT & delivery)

Sports & Recreation

2022/319 (2022/256) Responses have come in re; Consultation on proposed skate park – Clerk will formulate the replies for the next meeting in September

2022/320 Maintenance log for July completed by Cllr Mark. Cllr Mrs Vivien Holloway offered to complete for August with the help of Cllr Mike Lloyd.

2022/321 Invoice from Clira for Legionella Monitoring during June 2022

2022/322 Four Crosses Football Club have reported that the senior goal posts have been broken – complaint also received from resident that there is no senior goal posts for children to train with. It was suggested that the Football Club put up a notice explaining why the goal posts to allow the re-seeding to establish. They would also be used to secure these goal posts to prevent children from trying to erect them which may cause a serious accident. Cllr Bill Lee offered to repair the goal posts and would take a welder down onsite.

2022/323 Clerk to ask ORP price to add another camera as damage has been done to the boards on the Garage and graffiti to the dug-outs. Clerk has asked PCSO if the Police patrols could be increased.

2022/324 Paragon Cycling used the Clubhouse in July

2022/325 Llanfechain Football Club reminded re; outstanding Invoice from last Winter – to be reviewed at the next meeting

2022/326 Invoice received from Hafren Dyfrddwy which showed an increase in the water supply – Clerk meeting with an Engineer the following Friday to check there are no leaks.

2022/327 Email received from owner of 15 Vrynwy Crescent asking for permission to make an access for a mini-digger from the Sports Field and to site a skip on the carpark. Councillors agreed to this provided this is done within a reasonable timeframe, anything left on the Sports & Recreation Field is secured and that the site is left clear afterwards.

County Cllr Arwel update

2022/328 (2022/256) County Cllr Arwel had received a reply from the North & Mid Wales Trunk Road Agency to say that they had received any other complaints of noise from other Trunk Roads which have been re-surfaced. Cllr Arwel was asked to find out which other roads have been re-surfaced with a similar tarmac.

2022/329 (2022/265) North & Mid Wales Trunk Road Agency had replied to complaints received about vehicles failing to stop for pedestrian lights on the A483 to see that they are doing a review of the warning signs and also looking at removing/reducing the shrubs from the centre of the roundabout 2022/330 (2022/265a) Cllr Arwel had circulated details fo work undertaken in his role as County Councillor during the month which included a meeting with regard to the garages at Llys Rhysnant. They are looking at repairing and repainting some of these. Cllr Frances was disappointed that she had not been consulted as the local Councillor as the feeling was with her neighbours that the garages at the bottom of Llys Rhysnant should be demolished to allow for extra car parking. Cllr Arwel agreed to find out more details as to which garages are currently rented and report back at the next meeting.

2022/331 Cllr Arwel had also met with Calum Carr, Footpath Officer re; possible diversion of footpath at Greenfields Farm.

2022/355 Clerk has reported a problem with displaying the contact information on Councillors to Glvoersure.

Any other business

2022/355 External box has now been wired at Morrison's Local to house the Defibrillator– many thanks to the Ashton family.

2022/356 It was agreed that the Clerk will include under the Agenda Item for Members of the Public to speak a reminder that under the Standing Orders that this is limited to 5 minutes per person.
