2017/206 Minutes of the Annual Meeting held on Thursday 26th May 2016 were circulated, confirmed and signed.

2017/207 Powys County Council had confirmed an uncontested Election with 9 Councillors standing for Llandysilio. It was proposed by Cllr Frances Buckingham and seconded by Cllr D K Evans that Mathew Edwards be co-opted to fill the one vacant seat.

2017/208 Chairman's Report – Cllr C M Jenner thanked Chris Gilliard and Colin Benbow for all their hard work as Councillors and welcomed Stuart Page and Mathew Edwards onto the Council. He thanked Carol as Clerk for all her work and help given during the year. He felt quite despondent at how Powys County Council were ignoring the views of the local communities particularly in relation to planning issues. On a positive note the Council has managed to halt the development of the Four Crosses Inn and is in the process of buying 2 defibrillators for the Village. The delivery of the Wind Farm components was managed better than anticipated although we are still waiting for the replacement of the chevron on the roundabout. He wished the new Chairman well for the forthcoming year and the challenges ahead.

2017/209 The Chairman was congratulated on his year as Office and thanked for all the time and work put in.
